- 8. Platinum service on 3rd party equipment specifically excludes X-ray sources, X-ray detectors and PC's and 3rd party call-out charges.
- 9. RPA/RPE regulatory compliance evaluations are performed by an HSE-approved Radiation Protection Advisor.
- 10. Failure to provide access for planned work will result in forfeiture of the visit.
